## CAMBRIDGESHIRE HEARING HELP CIO

We are a local charity, originally formed in 1978 as the Cambridge Campaign for Tackling Acquired Deafness - CAMTAD.

Our aim is to help people with hearing loss or deafness in Cambridgeshire, for the purpose of removing or reducing the limitations caused by those conditions on the ability to communicate and to enjoy life.

Our 100+ volunteers and small team of staff achieve this aim via the delivery of:

- 40+ community-based NHS hearing aid maintenance clinics across the county through which we maintain approx. 15,000 hearing aids per year.
- NHS hearing aid maintenance home visits and residential home visits, through which we maintain approx. 3,000 hearing aids per year.
- Advice sessions, talks, displays, and equipment demonstrations.

Our vital work is a lifeline for older people/people with disabilities who struggle to/are unable to access mainstream NHS audiology services.

We are reliant on charitable donations and any support you can give will make a real difference.
